10. URBAN SEAGULLS IN THE MORAY AREA

There was submitted a report by the Director of Environmental Services detailing what steps if any, the Council would take to address the potential risks to health arising from the apparent increase in the seagull population.

Following consideration the Group agreed that:-

- (i) The Environmental Health Section continues to provide information and advice on the control of gulls in line with current practice.
- (ii) The Moray Council makes arrangements to remove nests and proof buildings in their ownership as necessary in line with current practice.
- (iii) Householders be discouraged from feeding Seagulls.
- (iv) Wheelie Bins continue to be used for the storage of refuse.

11. PLASTIC RECYCLING IN MORAY SCHOOLS

There was submited a report by the Head of Development Services providing an assessment of the feasibility of rolling out a programme of plastic recycling at Moray Schools.

Following consideration the Group agreed that plans for the collection of plastics from schools should be put on hold until the outcome of the ongoing investigations into the future of waste collection and treatment in Moray is known.
