Single Outcome Agreement

The Acting Chief Executive gave a short presentation to the Board on progress with the Single Outcome Agreement. Following discussion it was agreed that a special meeting of the Board be held at which a workshop would be held to facilitate discussion and agreement on the objectives and outcomes for the SOA.

The Special Meeting was held on Wednesday 7 December 2011 at 2.00pm at Moray College. Four main priorities were agreed; Alcohol, GIRFEC, Moray Economic Strategy and Social Inclusion. Two additional meetings will be held in January and February 2012 to look further at Outcomes.

It was agreed at this meeting that the next cycle of Theme Group meetings scheduled for January to March 2012 will be cancelled.
